“Building Tomorrow: Key Challenges for Builders into 2030.”

Presenter: Phil Crone, Leading Builders of America

This big picture of the residential construction market will include workforce challenges and the impact of climate change and current and proposed regulations intended to combat it, and the implications for Texas builders and the industry.

Phil Crone joined the Leading Builders of America (LBA) in 2023. LBA represents 21 of the nation’s largest homebuilders that collectively build 45 percent of the nation’s new single family homes. Phil serves as the focal point for the organization’s state and regulatory advocacy. He works closely with LBA members to advance housing-centric policy and political priorities in key states and directs the LBA’s advocacy activities in codes and standards with a particular emphasis on the International Energy Conservation Code.

Prior to working for LBA, Phil worked for the Dallas Builders Association starting in 2006 and served as its Executive Officer beginning in 2013. During that period, he received the New Executive Officer of the Year Award from the National Association of Home Builders as well as the Executive Officer of the Year Award. Phil played a key role in establishing a program for construction management and trades training at a local community college and chairs its Construction Advisory Committee. At the onset of the COVID-19 Pandemic, Phil worked with local leaders to keep the housing industry essential and operational, writing guidelines intended for safe operations.

Phil has a Bachelor’s degree from Purdue University and a Juris Doctorate from Southern Methodist University.

10:45 – 11:45 a.m. “Protect Your Business with TAB’s Texas-specific Residential Construction Form Contracts”

With the 2023 Regular Session of the Texas Legislature under our belts, TAB has released its contracts package for the 2023 – 2025 license cycle on September 1, 2023. This is your opportunity to learn about the new required Texas-specific forms and revisions to existing contracts. Talk with two of the attorneys who have been instrumental in the writing and updating of TAB’s form contracts and other industry forms. There are more new forms and changes this cycle that have greater implications on builders than ever before. The new contract package is mandatory to comply with the 2023 legislative session, including the statute of repose.

Donald Shelton is a managing shareholder of the firm and concentrates his practice in the trial and arbitration of commercial and residential construction law disputes, insurance defense, mechanic’s lien laws, bond claims, commercial landlord/tenant disputes, homeowner association disputes, and title insurance defense. Texas Capitol Update

Presenters: Scott Norman, CEO, Texas Association of Builders (TAB)

Learn about the latest from the Texas Capitol, as we look toward the legislative session that will convene in January 2025. Half of the Texas Senate's and all the Texas House of Representatives' seats are on the November ballot, and TAB is closely monitoring all the contested races while working with the those who do not have opponents and will be members of the 89th Legislature. Scott will discuss the Interim Charges that Lt. Gov. Dan Patrick and House Speaker Dade Phelan have issued that could have an impact on the residential construction industry as bills begin to be filed the first Monday after the November general election. This education session will give you a glimpse into all the hard work that our government relations team does year-round, whether the legislature is in session or not, to protect the Texas homebuilding industry.

M. Scott Norman, Jr. serves as CEO for the Texas Association of Builders (TAB) which represents nearly 10,000 homebuilder, remodeler, developer and associate members and their companies from across the state. He leads the government relations and political activities of the association as well as manages the second largest builders association in the nation. TAB member companies, suppliers and affiliated businesses in the Texas residential land development and construction industry are responsible for over 758,000 jobs and over \$71.5 billion annually to the Texas economy.

Mr. Norman has been actively involved in state government activities for over 28 years as both a Texas Capitol staffer, association executive and as a registered lobbyist. Scott is a founding and current board member of the Texas Builders Foundation, working to support and develop the future of Texas' construction workforce and facilitate the charitable activities of the residential construction industry. He is also the Texas Workforce Commission's appointment to the Jobs & Education for Texans (JET) Advisory Board that administers the state's grant program for schools to purchase and install equipment for career and technical education courses. Additionally, he is proud to serve on the Advisory Board of Operation Finally Home, a non-profit organization that has completed and donated over 340 home projects in 33 states to America's military heroes and the widows of the fallen.
